

SETTLEMENT AGREEMENT AND GENERAL RELEASE

This Settlement Agreement and General Release (“Settlement”) is entered into by the Charging Parties, listed on Attachment “A” to this Settlement, and the Respondent University Professional And Technical Employees, CWA, Local 9119 (“UPTE”) in these matters in order to resolve their disputes without further litigation. It is the intention of the parties that this Settlement shall fully and completely resolve all issues that were raised in the litigation, as between the Charging Parties and the Respondent. To that end, the parties, through their respective attorneys and representatives, in consideration of the mutual promises set forth below, agree as follows:

Refund of 2004-05 Agency Fees. Within 30 days of execution of this Agreement, UPTE will refund to Charging Parties and to any challengers in arbitration all agency fees paid or deducted during the 2004-05 fee year (i.e. July 1, 2004 to June 30, 2005), less any amounts Respondent has already rebated or refunded, plus 7% interest, compounded on an annual basis. The envelope containing the check will state on the outside in all caps, “REFUND CHECK ENCLOSED.”

Returned Checks. If the refund check is returned by the post office, the Respondent will use all reasonable methods to locate the current address of the

Charging Parties and secure the delivery of the refund checks. After such reasonable efforts, Respondent will notify Milton Chappell and Werner Witke, representatives of the Charging Parties, within fifteen days of Respondent concluding it has no current mailing address for an objector and NRTW will have fifteen days from such notice to obtain and provide Respondent with current mailing addresses for Respondent to use.

General Release and Binding Effect. The terms of this Settlement shall be binding upon the Charging Parties and the Respondent and their respective heirs, successors, assigns, and agents. This Settlement shall fully and finally resolve and release any and all claims by the Charging Parties with respect to Respondent's Hudson Notice distributed in September, 2004, and the collection of agency fees under that Notice for the 2004-05 fee year (i.e., July 1, 2004 to June 30, 2005). While Werner Witke and Milton Chappell, the undersigned representatives of the charging parties, do not represent any parties with respect to arbitration proceedings concerning challenges to the allocation/calculation of chargeable and nonchargeable expenditures under the Hudson notice distributed in September, 2004, said undersigned representatives agree not to participate in any such arbitrations regarding said Hudson notice.

No Inference of Liability. The parties expressly recognize that they are entering into this Settlement as a compromise of disputed claims, solely in order to avoid the considerable expense that would be entailed in litigation... In particular, the parties agree that the execution and implementation of this Settlement shall not give rise to any inference whatever that Respondent has violated any statutory or constitutional right of the Charging Parties.

Joint Motions. Within 15 days of the distribution of the refund checks, the affected parties will file: a) a joint motion with PERB to vacate its decisions in Nos. 1817-H, 1818-H, 1819-H, 1820-H, 1821-H and dismiss the pending Motions for Reconsideration in those decisions as moot; and b) a joint motion with PERB to withdraw any complaints issued on behalf of any of the Charging Parties herein. However, the parties expressly agree that the Settlement is and remains fully effective and final regardless whether PERB grants or denies the joint motions.

Withdrawals. Within 15 days of the distribution of the refund checks, the Charging Parties will withdraw with prejudice any pending unfair practice charges and any administrative and civil complaints filed by them or on their behalf with respect to Respondent's Hudson Notice distributed in September, 2004, and the collection of agency fees under that Notice for the 2004-05 fee year (i.e., July 1, 2004 to June 30, 2005).


Respondent's Future Hudson Notices. If PERB does not vacate PERB's Decisions Nos. 1817-H, 1818-H, 1819-H, 1820-H, 1821-H, then in such event Respondent will agree that future Hudson notices will include an audited breakdown of chargeable and nonchargeable expenses, unless not required by clear language in future caselaw from the California Courts, Ninth Circuit Court of Appeals or the U.S. Supreme Court.

Facilitation of Compliance. The parties agree to take all necessary actions to facilitate full compliance with this Settlement.

Execution of the Settlement Agreement. This Settlement shall be executed by the attorneys and representatives of Charging Parties and by the attorneys for the Respondent, who each warrant that they have the authority to bind their respective clients.
